Good Shepherd Parish was a part of the Metropolitan Community Church organization, meaning it was an explicitly gay affirming church during its operation from 1974 to 2004. It was heavily involved with many local and national movements focused on decriminalizing homosexuality, as the goal of the Metropolitan Community Church organization was to provide a place for gay Christians (which, at the time, was seen as an oxymoron). They also performed same-sex unions for gay couples in lieu of legal marriage.

Scope and Content:

The majority of the contents are board/committee meeting minutes, newsletters, and bank statements. There are also some letters both to and from the Church, as well as photographs and recordings of sermons.
